

**YOU MAY BE ELIGIBLE FOR SENIOR CITIZENS TAX EXEMPTIONS.

**APPLICATION MUST BE FILED WITH ASSESSOR  
FOR THE TAXING JURISDICTION BY TAXABLE STATUS DATE.  
TAXABLE STATUS DATE CAN BE OBTAINED FROM THE ASSESSOR'S OFFICE.**

### **THIRD PARTY NOTIFICATION**

If you are 65 years of age or older and/or disabled and you own and occupy a 1, 2 or 3 family residence, you may designate a consenting adult third party to receive duplicate copies of your tax bills and notices of unpaid taxes. Applications may be obtained in person from your tax collecting officer, County Real Property Tax Services, or by mail if you include with your request a self-addressed stamped envelope. Applications for third party notifications must be filed with the proper tax collecting officer no later than the dates shown in the table below:

**Exemptions and Exemption Renewals are accepted from January 2nd until March 1, 2024**

**VETERANS: (RP-458)** Veterans may be eligible for a Veteran's Exemption, now to include the Cold War Period.

**SENIOR CITIZENS: (RP-467)** You may qualify for a senior citizens exemption, you must be 65 by March 1, 2024 and income must be less than \$37,899.

**NEW HOME OWNERS or HOME OWNERS NOT RECEIVING THE BASIC STAR: School Tax Relief (STAR) CREDIT:**  
(RP-425-B) Income limit less than \$500,000.

**HOME OWNERS NOT CURRENTLY RECEIVING ENHANCED STAR: School Tax Relief Enhanced (STAR) CREDIT:**  
(RP-425-E) w/Individual Verification Program (IVP)

Must be 65 prior to December 31, 2024 with Income Limit less than \$98,700.
